Event: Revenues and gross margin on sales for October released.

Yesterday, during the WSE trading hours, Action revealed preliminary revenues and gross profit margin on sales for October. **The Group's consolidated revenues** reached **PLN 218 million** (down 2% yoy), while the gross profit margin on sales stood at 7.5% (up 0.3 pp mom and down 0.3 pp yoy).

**Expected impact:** Neutral, as the news reached the market during yesterday's session. We cannot preclude that the reported margin will prove higher finally which was the case in previous quarters. On the other hand, the sales decline is below the Company's ambitious targets for this year, as it aims at a 5-10% yoy growth pace.
