What is this product?

Type

The product is a share class of the Sub-fund Franklin Future of Food UCITS ETF (the "Fund") which is part of the Franklin Templeton ICAV (the "Umbrella Fund"), an Irish collective asset-management vehicle constituted as an umbrella fund with segregated liability between Sub-Funds with registration number C167746 and authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To provide exposure to companies that are involved in sustainable practices across the food industry globally.

Investment Policy

The Fund invests in equities of developed market companies that utilise technology, efficient production and supply practices, and/or demonstrate innovation with the aim of creating a sustainable food ecosystem, such as sustainable and healthy food, agriculture machinery, smart farming, packaging solutions and water technology. These investments are included in the benchmark.

To be included in the Index, such securities have, or are expected to have, exposure to the provision of products and/or services within the food industry. These companies operate in industry categories such as sustainable and healthy food, agriculture machinery, smart farming, aquaculture, packaging solutions and food supply, crop protection & nutrients or water technology.

Index Securities are selected from the Solactive GBS Developed Markets All Cap Index (the "Parent Index") based on screening publicly available information such as financial news, business profiles and company publications using the Index Provider's proprietary natural language processing algorithm.

Derivatives and techniques The Fund may use derivatives for hedging and efficient portfolio management.

Strategy The investment manager seeks to minimise the difference between the Fund's performance and that of the benchmark (tracking error), regardless of whether the benchmark level rises or falls.

SFDR category Article 8 (promotes environmental and/or social characteristics under EU regulations).

The benchmark consists of companies with higher environmental, social and governance (ESG) ratings relative to their sector peers. It also excludes or restricts investments in certain industries that are harmful to the environment or society, such as fossil fuels, weapons and tobacco. The Fund also invests significantly in sustainable investments.

The Fund is passively managed and seeks to replicate the benchmark by holding all of the Index securities in a similar proportion to their weighting in the benchmark. Its portfolio, and thus its performance, closely resemble that of the benchmark.

Share Class Policy

For accumulation shares, income from investments is reinvested in the Fund and reflected in the price of shares.

Buying and selling shares

You may buy or sell shares daily through a broker on the stock exchange where the shares are traded. Authorised participants, such as selected financial institutions, may buy or sell shares directly with the fund, on any day the London Stock Exchange is open for business (provided that on such day the markets on which substantially all of the Fund's investments are traded are open).

Intended retail Investor

Investors who understand the risks of the Fund and plan to invest for at least 3 to 5 years. The Fund may appeal to investors who:

- are looking for long-term investment growth
- are interested in a thematic exposure to equity markets as part of a diversified portfolio
- have a high risk profile and can tolerate significant short-term changes in the share price

Product availability The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. State Street Custodial Services (Ireland) Limited, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:
