#### Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

#### **Produc**

iShares MSCI ACWI SRI UCITS ETF (the "Fund"), USD Accu (the "Share Class"), ISIN: IE000JTPK610, is authorised in Ireland and manufactured by BlackRock Asset Management Ireland Limited (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Ireland and regulated by the Central Bank of Ireland (the "CBI") and the CBI is responsible for supervising the Manager in relation to this Key Information Document.

#### What is this product?

**Type:** The Fund is a sub-fund of iShares IV plc, an umbrella company incorporated in Ireland, authorised by the Central Bank of Ireland as a Undertaking for Collective Investment in Transferable Securities ("UCITS"). The Fund is a UCITS exchange-traded fund, a UCITS ETF.

**Term:** The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

### **Objectives**

- The Share Class is a share class of a Fund which aims to achieve a return on your investment, through a combination of capital growth and income, which reflects the return of the MSCI ACWI SRI Select Reduced Fossil Fuel Index ("Index").
- The Share Class, via the Fund, is passively managed and aims to invest so far as possible and practicable in the equity securities that make up the Index.
- The Index measures the performance of a sub-set of equity securities within the MSCI ACWI Index ("Parent Index") with higher Environmental, Social and Governance ("ESG") ratings relative to their sector peers within the Parent Index, based on a series of exclusionary and ratings based criteria. Companies are excluded if they are involved in certain business lines/activities, as outlined in the Index description of the Fund in the Fund's Prospectus. Companies that are in violation of United Nations Global Compact principles or OECD Guidelines for Multinational Enterprises are also excluded from the Index. The remaining companies are rated by the index provider based on their ability to manage ESG risks and opportunities and are given a MSCI ESG rating which determines their eligibility for inclusion. Companies are also excluded based on an MSCI ESG controversy score (very severe).
- The Fund adopts a best-in-class approach to sustainable investing, this means that it is expected that the Fund will invest in the best issuers from an ESG / Socially Responsible Investment ("SRI") perspective (based on the ESG/SRI criteria of the Index) within each relevant sector of activities covered by the Index.
- The Index targets a 25% representation from each Global Industry Classification Standard sector within the Parent Index. Eligible companies in each sector are ranked by criteria as outlined in the Fund's prospectus Eligible companies from each sector are included in the Index in a specific order, as defined by the index provider in the index methodology, up to 25% representation
- The Index is free float adjusted market capitalisation weightedConstraints are applied to limit deviation from the index's constituent and sector weights...
- The investment manager may use Financial Derivative Instruments ("FDIs") to help achieve the Fund's investment objective. FDIs may be used for direct investment purposes.
- The Fund may obtain limited exposure to securities which do not satisfy the ESG criteria.
- The Fund may also engage in short-term secured lending of its investments to certain eligible third parties to generate additional income to off-set the costs of the Fund
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of your investment.
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is State Street Custodial Services (Ireland) Limited.

- Your shares will be accumulating shares (i.e. income will be included in their value).
- Your shares will be denominated in US Dollar, the Fund's base currency.
- The shares are listed and traded on various stock exchanges. In normal circumstances, only authorised participants may buy and sell shares directly with the Fund. Investors who are not authorised participants (e.g. select financial institutions) can generally only buy or sell the shares on the secondary market (e.g. via a broker on a stock exchange) at the then prevailing market price. The value of the shares are related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below). The prevailing market price at which the shares trade on the secondary market may deviate from the value of the Shares. Indicative net asset value is published on relevant stock exchanges websites.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

## What happens if BlackRock Asset Management Ireland Limited is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, State Street Custodial Services (Ireland) Limited (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

#### What are the costs?
